The signatory further guarantees that he or she has the necessary permissions to use all material protected by copyright (external text or picture documents) published with the contribution. He or she thus promises to release the ÖGMN from all claims by third parties connected to a use for which he or she is responsible.
- 4. The author or authors promise not to distribute early versions or proofs, either before or after publication of the printed version. Following publication of the BMÖ every author will receive the final version of the contribution in electronic form and is allowed to distribute this specific PDF and to make it available online. The electronic copy (always including the preliminary matter) may only by used and circulated unchanged. his embraces both physical and electronic copies and also the uploading of an electronic version to be read or
  - downloaded in the internet. The necessary prerequisite is that the author or authors possess all necessary rights and take into account the relevant and up-to-date legal circumstances.
